SUSTAINED STRONG GROWTH: +19.6%

Cavaillon, January 30th 2012 – ID Logistics' group revenue for 2011 was 462M€, an increase of 19.6% over the previous period. Excluding currency effects, revenue increased by 16.5%.

STRONG GROWTH BASED ON A PERFORMING BUSINESS MODEL

Since its creation in 2001, ID Logistics' revenue increased from 20M€ to 462 M€, essentially by organic growth. In 2010, revenue had increased by 24,5%.

« Pure player » in contract logistics, ID Logistics' core business is with retail, from manufacturers to retailers, and from retailers to their stores. ID Logistics answers globally to its clients' logistics needs, provides a high level of reliability, and implements innovative solutions, largely based on technology. For the past ten years, ID Logistics has been operating overseas, notably in China and Brazil, and is able to support its clients in their development in high growth markets. In 2011, 36% of ID Logistics' revenue was generated overseas.

This unique and dynamic position allowed us to develop and nurture a solid client base among the most prestigious retailers and manufacturers, and to be successful in an important proportion of the tenders submitted to us.

In 2011, several new clients contracted with ID Logistics: Simply Market, Grosbill, Auchan.fr, Plateforme du Bâtiment (Saint Gobain Group) and PPG in France, Caterpillar in Brazil, Ambev in China and Zywiec Zdroj (Danone) or Südzucker in Poland. Furthermore, existing clients have expanded their activities with the group, by awarding businesses in new countries: Leroy Merlin, Auchan or Carrefour.

TAKEOVER OF GROUPE MORY'S LOGISTICS BUSINESS AT THE END OF 2011

At the end of 2011, ID Logistics bought the logistics business unit of the MORY group. Today, these 10 warehouses are completely integrated, and increase the size of our operations in Western France, and develop our know-how in high-quality industrial logistics, thanks to clients such as Yves Rocher, Rémy Cointreau, SNECMA or SOGEFI.
