## ID LOGISTICS OPENS IN PARTNERSHIP WITH DOCILE ANOTHER DISTRIBUTION CENTER IN EXTREMA (MG)

ID Logistics, the Brazilian subsidiary of the ID Logistics Group, a European leader in contract logistics, inaugurates a distribution center of Docile, a 100% Brazilian company and the main exporter of the segment in the country, in Extrema, south of Minas Gerais. The operation has a modern infrastructure that includes digitization of all internal controls, in addition to unifying the two previous smaller sites used by the company for the distribution of its products.

Docile is present in Brazil and in more than 80 countries. It has a portfolio of 170 items, traditional and premium, divided into seven categories: gummy candies, gummies, regaliz, chewing gum, jelly candies, powdered soft drinks and marshmallows, the company's flagship, which was the first to offer the filled option of the candy. In the market for more than 30 years – with factories in Lajeado/RS and Vitória de Santo Antão/PE – it was born by family entrepreneurship and is driven by the delight of making sweets and discovering the new, without losing its essence. Its positioning is "Being sweet to create a sweeter world" and is proud to be the brand that spreads kindness wherever it is.

The new distribution center has a total area of 5,395 m<sup>2</sup>, where 375 SKUs will be handled in 5,222 pallet positions. This operation has a *single deep* pallet structure, which facilitates

quick access and movement of goods, since the operation has a large volume of items and high inventory turnover. The site employs 50 employees who will work in two shifts.

*«This new DC is in a strategic position for us to serve the Southeast region and part of the Midwest, fundamental for our continuous growth in the national market. We produce more than 4 million kilograms of treats per month and have a very automated manufacturing system. Logistics has to be in line with our pace of modernization and also enhance the expansion of the business," says Docile's Supply Director Charles Rommel Xavier.*

In addition to the zero use of paper, with the integration of an electronic checklist and radio frequency control, the high contribution of technology in the operation includes E-cokpit (operational management), CTIV (Yard Management), Countback (cyclical inventory in case picking), Electronic Concierge (greater control of inputs and outputs in the DC), Triangulation (speeds up the delivery of the product to the final consumer) and WMS solutions.

Sustainable warehouse delivery includes wastewater treatment and recycling plants and the use of photovoltaic panels for power generation.
