ID LOGISTICS SUPPORTS INTERMARCHÉ IN THE SEARCH FOR A SITE IN THE CENTRE-EAST REGION, SELECTS THE SITE IN SAINT-BONNET-LES OULES AND THUS MAINTAINS 200 JOBS

ID Logistics, an international leader in contract logistics, signed a 6-year contract with Intermarché on October 1st, 2024, for the takeover of the activities of a logistics site located in Saint-Bonnet-les-Oules, near Saint-Étienne. This new operation is part of the acquisition of the 294 Casino stores by Intermarché (Groupement des Mousquetaires). The takeover of the site by the logistics company maintains a quasi-continuity of activities and ensures the positions of the 200 employees already present. This 52,000 m² site will serve 87 Intermarché stores located in the Centre-East regions.

A HISTORIC CASINO LOGISTICS WAREHOUSE

Initially created by Casino, the Saint-Bonnet-les-Oules site occupied a central place in the brand's logistical organization. It supplied hypermarkets, supermarkets and other convenience stores throughout France. The warehouse mainly stored dry products but also sweet/savory grocery products, drugstore/perfumery/hygiene products, etc. Located near the company's headquarters in Saint-Etienne, it employed more than 200 people.

RAPID TAKEOVER TO ENSURE BUSINESS CONTINUITY

As part of the takeover of the 294 Casino stores by the Groupement Les Mousquetaires, Intermarché - a long-standing customer of ID Logistics since 2002 - has chosen the logistics company to take over the management of the Saint-Bonnet-les-Oules site and quickly integrate it into its current logistics plan to cope with the additional volumes generated by the integration of the new stores.

Spread over 52,000m², the site is responsible for receiving, preparing and shipping orders, as well as cross-docking, stock management and returns. It will supply 87 Intermarché stores in the Centre-Est region with non-fresh food products (groceries, drugstores, soft drinks, hygiene).

A TRANSFORMATION AND PRESERVATION OF JOBS CHALLENGE FOR ID LOGISTICS

This site required an upgrade on many points to comply with the Group's expectations and ID Logistics' standards:

- **Restoration of the property**: ID Logistics carried out work to bring the building into compliance, particularly with regard to the ICPE authorizations (Classified Facilities for the Protection of the Environment), the development of the site to adapt to the new flow of goods, and the rehabilitation of the roads.
- **Bringing customer needs up to standard**: with the adaptation of Intermarché's Infolog WMS for the Saint-Bonnet-les-Oules site.
- **Complete renewal of handling equipment**: ID Logistics has installed new handling equipment in order to comply with the logistics company's standards and upgraded the site's signage, particularly that relating to quality/safety at work.
- **Job preservation**: Located in the Auvergne-Rhône-Alpes region, the Saint-Bonnet-les-Oules site is located in a fragile economic and social basin. With this resumption of activity, ID Logistics is supporting Intermarché in safeguarding the jobs of more than 200 employees previously hired by Casino.
- **Team training**: the logistics company provides training plans to make employees fully operational for their new missions. The CACES training will be fully covered by the company for each of the employees concerned, an upgrade of Intermarché processes as well as training on health and safety at work will be delivered to them. ID Logistics will also offer these 200 employees an internal training system to increase their skills, as well as a job exchange for all those who would like to benefit from mobility in France.

Finally, once the transformation operation is completed, the site is intended to welcome other customers of the logistics company, if necessary.
